## Aim

The Trust aims to provide growth in capital value and dividends over the long term by investing in global and UK securities. The benchmark against which performance is measured is 70% FTSE World ex-UK Index and 30% FTSE All-Share Index.

## History

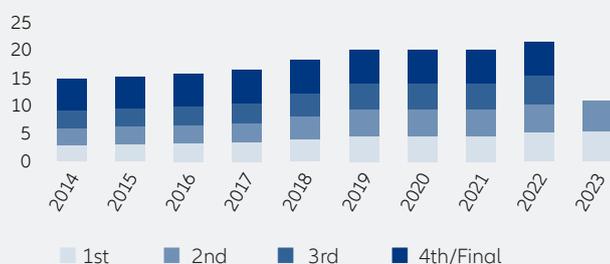
The Brunner Investment Trust PLC was formed from the Brunner family's interest in the sale of Brunner Mond & Co, the largest of the four companies which came to form Imperial Chemical Industries (ICI) in 1926. Today, Brunner shares are available for everyone to buy and are widely held by both private and institutional investors.

## Trust Benefits

Brunner aims to provide its shareholders with growing dividends and capital growth by investing in a portfolio of global equities. It is an independent company listed on the London Stock Exchange and, although past performance is no guide to the future, has paid increasingly higher dividends to its shareholders year on year for the last 51 years. The Trust invests in companies all over the world, seeking out opportunities for growth and reliable dividends wherever they may be.

## Fund Manager's Review

Dear Shareholder,

Brunner outperformed during August, with a Net Asset Value (NAV) total return of -0.71% vs -1.41% for the benchmark.

All of the outperformance this month was achieved via stock selection, as opposed to the outcome of sector or regional weights. Given our 'all weather' approach this is how we prefer things, with performance driven by selecting the best individual businesses rather than by taking views on broader stylistic or macro-economic factors.

The most significant positive contributors to performance this month were Novo Nordisk, Admiral, AJ Gallaher and Visa:

Novo Nordisk is the Danish pharmaceutical giant. The recent success of its drugs Ozempic and Wegovy for diabetes and obesity was boosted by the results of its SELECT trial, which studied the impact of semaglutide (the ingredient in both Wegovy and Ozempic) on 'major adverse cardiovascular events (MACEs)' – ie heart attacks and strokes. The study demonstrated a statistically significant 20% reduction in MACEs, further expanding the market for this extraordinarily useful molecule.

Admiral, the UK motor insurance company, reported very strong results. These gave credence to our thesis that the UK motor insurance market was due for an upturn after a very difficult period caused, primarily, by the impact of inflation on claims expenses. In the first half of the year Admiral increased prices 23%, restoring profitability. Most competitors have now followed on price which should soon, we believe, allow Admiral to resume value-creative share gains.

US listed insurance broker AJ Gallagher is benefiting from the same effect. Globally, insurers are increasing rates to compensate for inflation and to restore profitability. AJ Gallaher places business on behalf of its clients and takes, generally, a percentage fee in return. The company's most recently reported 'organic' revenue growth (which excludes the impact of merger

& acquisition (M&A) and currency moves) was a very strong 11%, partially reflecting higher prices and demonstrating how select equities can act as something of an inflation hedge (a hedge is a financial strategy to protect against the risk of adverse price movements) – a factor we consider important for those looking to build and protect wealth over the long term.

Visa's top and bottom line also benefits from inflation. Visa takes a very

small percentage of every transaction conducted on its network, so higher prices equate to higher revenues. Despite talk of economies flirting with recession, it is important to note that nominal Gross Domestic Product (GDP) growth, which is unadjusted for inflation, remains strong. For example, reported (real) year on year GDP growth in the UK in Q2 was just 0.4% but was 7.1% in nominal terms. For businesses like Visa it is the nominal figure that is more relevant.

Microchip Technology, which makes microcontrollers and simple analog semiconductors used in a wide variety of industrial and consumer applications, detracted from performance, as did Charles Schwab, the US brokerage. Microchip's results led to modest downward revisions to earnings expectations; par for the course for cyclical companies like this. Charles Schwab is somewhat interest rate sensitive and accompanied US interest rates lower following a benign US inflation report.







## Environmental, Social and Governance (ESG)

AllianzGI has a dedicated ESG research team working with the portfolio managers to incorporate ESG factors into investment decisions. The board supports AllianzGI's view that there is value in working with companies in the portfolio on environmental, social, governance and business conduct issues.

AllianzGI uses third party research provided by MSCI to help identify ESG factors that can impact the businesses of the companies in the portfolio. The chart below shows that the Brunner portfolio's ESG ratings compare well against the benchmark's ESG ratings over a five year period.



The chart above shows the rating of the Brunner portfolio on ESG risks and combined ESG risk measurements compared to the rating of the Benchmark (70% FTSE World ex-UK Index; 30% FTSE All-Share Index) scored on a scale of 1-10 (where 10 is high) on a quarterly basis.

## Glossary

**Share Price** is the price of a single ordinary share, as determined by the stock market. The share price above is the mid-market price at market close.

**Net Asset Value (NAV) per Share** is calculated as available shareholders' funds divided by the number of shares in issue, with shareholders' funds taken to be the net value of all the company's assets after deducting liabilities.

The NAV figure above is based on the fair/market value cum income of the company's long term debt and preference shares (known as debt at fair value). This allows for the valuation of long-term debt and preference shares at fair value or current market price, rather than at final repayment value (known as debt at par).

**Premium/Discount.** Since investment company shares are traded on a stock market, the share price that you get may be higher or lower than the NAV. The difference is known as a premium or discount.

**Dividend Yield** is calculated using the latest full year dividend divided by the current share price.

**Gearing** is a measure of a company's financial leverage and shows the extent to which its operations are funded by lenders versus shareholders.
